**A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD

PROCEDURE FOR CONDUCTING A SPECIAL ELECTION TO
FILL THE OFFICE OF COUNTY COMMISSIONER – 2nd
DISTRICT**

WHEREAS, a vacancy now exists in the office of Henry County Commissioner in the 2nd District; and

WHEREAS, the Board of Commissioners of Henry County, Tennessee must fill the said vacancy which now exists; and

WHEREAS, a special election for the purpose of filling the said vacancy has been set by the Board of Commissioners of Henry County, Tennessee; and

WHEREAS, it is appropriate and necessary that certain rules and procedures for the conduct of the special election be established to insure the order and fairness of the said special election.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Henry County, Tennessee, assembled in regular session on this 16th day of January 2018, a majority or more of the membership concurring, that:

SECTION 1. Each candidate for the office of County Commissioner-2nd District, whose qualifications are accepted by said Henry County

Commission, be and hereby is granted the opportunity to speak to the assembled Commission in his/her own behalf prior to the casting of the official ballot or ballots; and provided, however, that any candidate so qualified may designate a person of his or her choice to speak in his or her own behalf; and provided, further, that in any event, the time granted for the speech or speeches on behalf of any candidate shall be for a period of time no longer than five (5) minutes.

SECTION 2. Any and all ballots shall be cast pursuant to the requirements of Section 5-5-116 of the Tennessee Code Annotated.

SECTION 3. To be elected, a candidate must receive the vote of a minimum of eight (8) Commissioners, pursuant to the requirements of Section 5-5-109 of the Tennessee Code Annotated.

SECTION 4. In the event that no candidate receives the eight (8) votes required for election on the first ballot, then the Commission shall proceed to the second ballot and any number of additional ballots necessary until one candidate receives the vote of a minimum of eight (8) of the Commissioners; provided, that before proceeding to a second or any subsequent ballot, the name or names of the candidate or candidates receiving the least number of votes on the previous ballot shall be deleted from the second or any subsequent ballot; and provided, further, that the names of a candidate or candidates shall not

be deleted from any ballot when such deletion would result in a ballot containing the name of only one (1) candidate that had received less than the eight (8) votes required for election.

WHEREAS, the Tennessee Attorney General opined in Opinion No. 92.47 that state and local governments are required to comply with Title VI of the Civil Rights Act in administering federally funded programs; and

WHEREAS, the Community Development Division of the Tennessee Department of Economic and Community Development administers the Three-Star Program and awards financial incentives for communities designated as Three-Star communities; and

WHEREAS, by virtue of the Tennessee Department of Economic and Community Development receiving federal financial assistance, all communities designated as Three-Star communities must confirm that the community is in compliance with the regulations of Title VI of the Civil Rights Act of 1964 and the Civil Rights Restoration Act of 1987.

NOW, THEREFORE, BE IT RESOLVED, by the county legislative body of Henry County, Tennessee, meeting in regular session on this 16th day of January, 2018, at Henry County Court House in Paris, Tennessee, that:

SECTION 1. The legislative body of Henry County, Tennessee declares that the county is in compliance with the federal Title VI regulations.

SECTION 2. The Department of Economic and Community Development may from time to time monitor the county's compliance with federal Title VI regulations.

RESOLUTION NO. 7-1-18

A RESOLUTION REQUESTING THAT THE CHANCERY COURT SET ASIDE THE DELINQUENT TAX SALE AS TO PARCELS PURCHASED BY HENRY COUNTY WHICH CONSTITUTE AN ECONOMIC AND ENVIRONMENTAL HARDSHIP

WHEREAS, Henry County, Tennessee, by and through its Delinquent Tax Attorney, prosecuted Tax Year 2014 delinquent tax lawsuit as required by Title 67, Chapter 5, Parts 24 and 25 of the Tennessee Code, resulting in a delinquent tax sale held on or about November 20, 2017; and

WHEREAS, as required by TENN. CODE ANN. § 67-5-2501, the Clerk & Master of the Henry County Chancery Court bid the debt ascertained to be due for taxes, interest, penalties, and the costs and fees incident to the collection thereof on parcels for which no other bidder offered the same or larger bid; and

WHEREAS, pursuant to TENN. CODE ANN. § 67-5-2507(c)(1), the Henry County Mayor has evaluated the parcels to determine whether the value of any particular parcel or amount of money the county is likely to receive if the county sold the parcel exceeds the financial obligations or environmental risks associated with the parcel; and

WHEREAS, pursuant to TENN. CODE ANN. § 67-5-2507(c)(2) If the County Mayor determines that such financial obligations or environmental risks exceed the value of any particular parcel, the county legislative body may adopt a resolution, by a two-thirds (2/3) vote, concurring in the County Mayor's determination and directing the County Mayor to request that the Chancery Court rescind its order confirming the tax sale as to those parcels; and

WHEREAS, the Henry County Mayor has determined (and the Henry County Board of Commissioners concur that), for the reasons stated below, the financial obligations and environmental risks associated with the following parcels far exceed the value of these parcels or amount of money the county is likely to receive if the county sold the parcels:

Map 030 L, Group F, Parcel 022.00. Reason: This parcel is the abandoned Puryear School building, which the Henry County School System sold after Puryear School and Cottage Grove School consolidated to form Harrelson School. No interested party bid the minimum necessary to purchase the parcel during the public tax sale, which was \$4,542.60. The structure located on the parcel is dilapidated. The cost to demolish said structure is estimated to exceed \$250,000.00, which is exponentially greater than the parcel's potential resale value. The cost to secure and maintain the structure located on the parcel also exceeds the parcels resale value and constitutes an undue financial obligation.

Map 117, Parcel 020.00. Reason: The Henry County Sheriff's Department has quarantined this parcel due to methamphetamine contamination. The cost to decontaminate the structure located on the parcel is estimated to cost thousands of dollars, which far exceeds its potential resale value. The cost of decontamination

constitutes an undue financial obligation. The parcel constitutes an obvious environmental risk.

NOW, THEREFORE, by a vote of over 2/3rds of its members, the Henry County Board of Commissioners, meeting in a regular session on this the 16th day of January, 2018, resolve as follows:

1. The Henry County Board of Commissioners concurs with the Henry County Mayor's determination that the financial obligations and environmental risks associated with the following parcels far exceed the value of these parcels or amount of money the county is likely to receive if the county sold the parcels: **Map 030 L, Group F, Parcel 022.00 and Map 117, Parcel 020.00.**
2. The Henry County Board of Commissioners authorizes and directs the Henry County Mayor, by and through the Henry County Attorney, to move the Henry County Chancery Court to rescind its order confirming the tax sale as to **Map 030 L, Group F, Parcel 022.00 and Map 117, Parcel 020.00** due to the financial burden and environmental risk of said parcels.
3. The Henry County Board of Commissioners urges the presiding Chancellor to rescind its order confirming the tax sale as to **Map 030 L, Group F, Parcel 022.00 and Map 117, Parcel 020.00** due to the financial burden and environmental risk of said parcels.
